Registration Form Tee Time Reservation System and/or Handicapping Service

This registration form must be completed and returned along with the annual fee form for POA members who are requesting either the Tee Time Reservation System (includes internet access) and/or Computer Handicapping Service.

Tee Time Reservation System – If you are registering for the Tee Time Reservation System (including internet access) only, it is not necessary to fill in the GHIN #. For Tee Time Reservation System participants, you will receive an initial password via e-mail, which you may change to a personal password. *If you registered for the Tee Time Reservation System Internet Access in 2005, your password will stay the same as it is now.* If you do not provide an e-mail address for your password, you will need to contact the Golf Department for your password.

Computer Handicapping Service – You do not currently have to be a member of GHIN to sign up for handicapping services. If you have a current USGA GHIN # (6 or 7 digit number) please provide. Please circle if you are requesting a 9-hole or 18-hole handicap. USGA GHIN handicapping services are provided through the Arkansas State Golf Association and the Arkansas Women's Golf Association. Gender is not a criteria for receiving services from either organization. If you are registering for Computer Handicapping Services only, an e-mail address is not required.

Please Note – The 6 digit POA assigned barcode number will be used for accessing both tee time and handicap services. Please call the Golf Department at 501.922.5549 with any questions.
